NEW MINIMUM WAGE EFFECTIVE JULY 1, 2016

This is a very sore topic with many! Nevertheless, for us Oregonians, effective July 1, 2016, the minimum wage is going from \$9.25 TO \$9.50 per hour. Many of you have already heard this. BUT...it's not actually the whole truth.

So here's what is really happening. Oregon has broken the state into 3 geographic areas: the "standard" area, the "Portland Metro" area, and the "nonurban counties" area (we fit here). For 2016 and 2017 here are the minimum wage figures broken out by these 3 areas.....

Date	Standard	Portland Metro	Nonurban Counties
1/1/2016	9.25	9.25	9.25
7/1/2016	9.75	9.75	9.50
7/1/2017	10.25	11.25	10.00

Note that the "standard" and "Portland Metro" areas are the same until 7/1/2017 when they start moving apart. Portland will be the highest minimum wage location in the state from that point on.

The "Nonurban Counties" are listed as follows:

IRS SENDS OUT MORE ERRONEOUS NOTICES

I guess, by now, that this kind of news should not surprise us anymore. Many taxpayers received what is called an "advance payment" on their health insurance premiums. Basically, a taxpayer contacts the "marketplace" at the beginning of a year and represents to them what they think they will earn over the year. Then, the marketplace determines if that person is eligible to receive help with their monthly premiums. One way this help is given is by them paying a portion of the monthly premium directly to the provider each month. This is called the "advance premium" method.

At any rate, at a later date when the ACTUAL earnings are known, the taxpayer may need to repay some of that if they earned more than they originally told the marketplace. This is typically done via the filing of a tax return.

However, the IRS went ahead and sent out 27,000 erroneous notices to taxpayers indicating that they did not qualify for any help and should pay it back. But these notices were wrong! To their credit, the IRS came right out and confessed.

In my experience, whenever the IRS gives us a number it is usually waaaaaay low! So, I don't know what the real number is, but I am willing to bet that it is MUCH higher than the 27,000 figure.

STILL VERY HARD TO CONTACT THE IRS

In 2015 the IRS Commissioner, John Koskinen, announced that more than 60% of taxpayer phone calls were going to be ignored during the 2015 filing season. While no stats are out yet about the tax season we just finished, I can tell you that our experience is that it hasn't gotten better. Their budget is still cut to the bone and that is having a LOT of unintended consequences for American taxpayers.



We are still finding that it is taking significantly longer to contact the IRS and resolve tax issues on behalf of our clients. And, to make matters worse, that means higher fees from us when representing a client. Not a good situation at all.
